



strategy description

Volatility is the standard deviation (a concept first introduced by Sir Francis Galton) of returns and is the traditional measure of financial risk. The best known volatility index is VIX, which measures the expected volatility of S&P500 returns. The large negative correlation (another concept invented by Galton) between VIX (tradable by the VXX ETN) and the returns themselves (tradable by the SPY ETF) can be exploited to construct a neutral (zero beta), hedged portfolio with very low volatility itself. It turns out that, in particular market conditions this portfolio embodies sizeable arbitrage opportunities. The Galton strategy exploits these to provide consistent positive returns.

Remarks:

- a) the VXX ETN exists only since the beginning of 2009; to obtain the statistics the ETN was simulated from its definition before 2009, starting 2009 real data were used;
- b) the results do not include transaction costs which would reduce the yearly average return by approximately 0.01%.

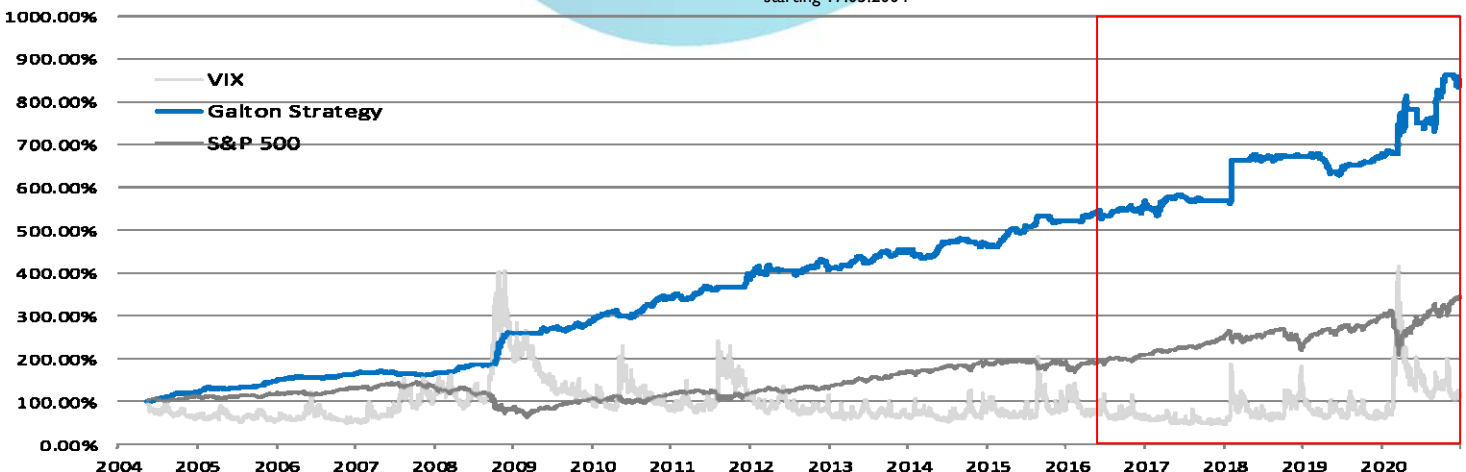
